KONTIKI FINANCE LIMITED (KFL) ANNOUNCES DIVIDEND REINVESTMENT PRICE

As announced through the South Pacific Stock Exchange on 22nd January 2020, Kontiki Finance Limited (KFL) declared a \$0.025 (two and a half cent) per share interim dividend. Under KFL's Dividend Reinvestment Plan, shareholders have the opportunity to reinvest the dividend into additional shares of KFL.

The Reinvestment Price will be \$1.18 per share. The Reinvestment Price is set at a 5% discount to the average share price over the month prior to the dividend announcement. Reinvestment into additional shares can be made without paying any brokerage fees or levies.

Shareholders who elect to participate in the reinvestment plan will receive newly issued shares. The number of shares will be equal to the total amount of dividend to which the shareholder is entitled (\$0.025 multiplied by the number of shares owned) divided by \$1.18. The number of shares will be rounded down to the nearest whole number.

Everyone who is registered as a shareholder in KFL on the Record Date can opt for the reinvestment plan. The Record Date will be on the 11th February 2020.
