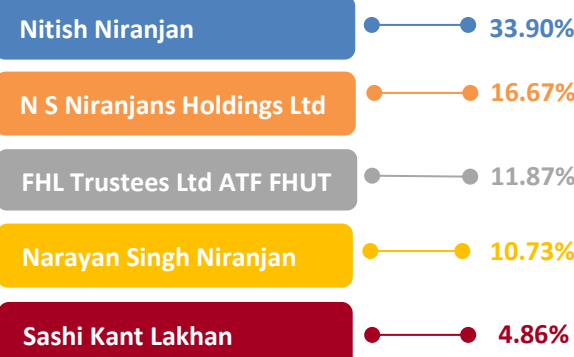

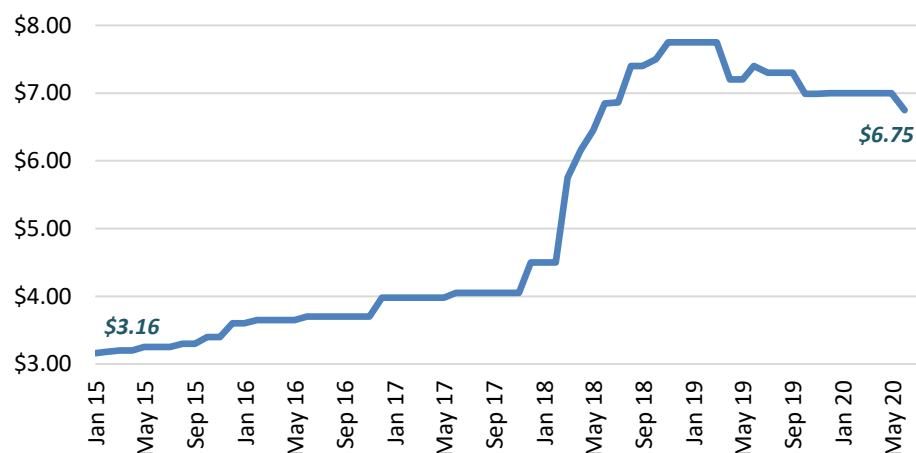

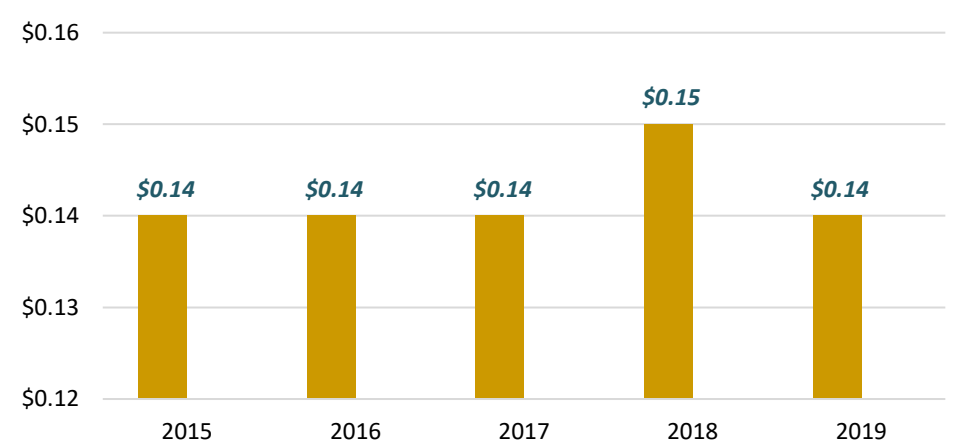
Share Price Performance

Dividend Payment History

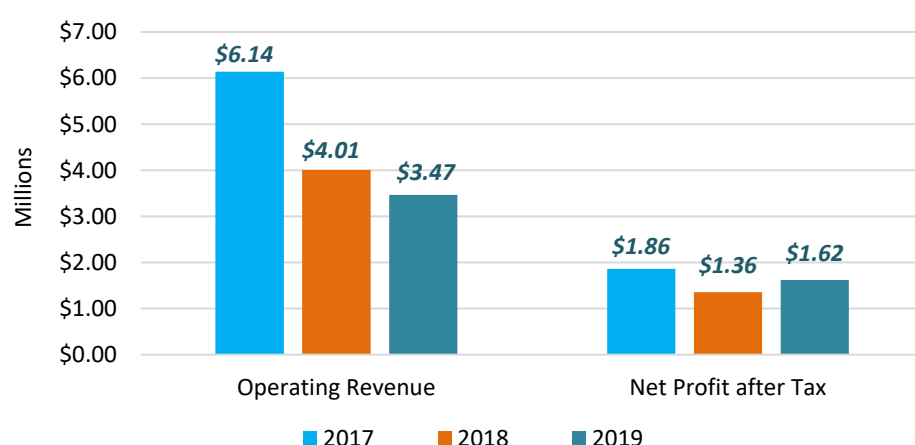
Dividend per share from 31st December 2015 until 2019 (based on financial year)



For the 2020 financial year, VBH has declared an interim dividend of \$0.07 per share

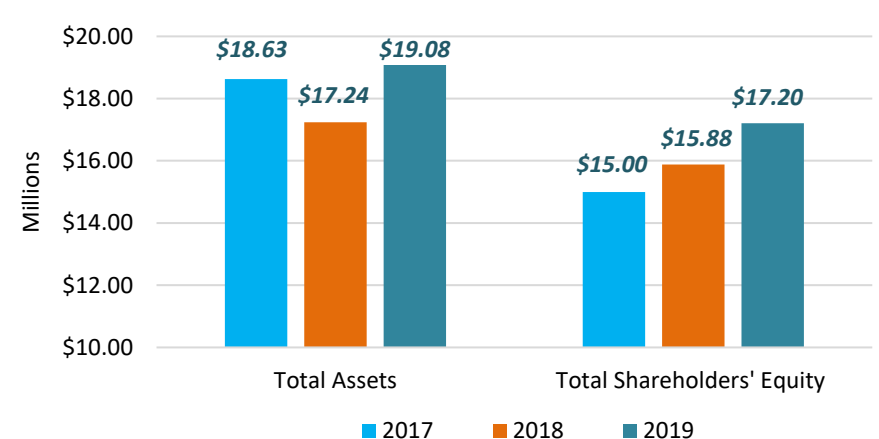
Financial Figures Trend
