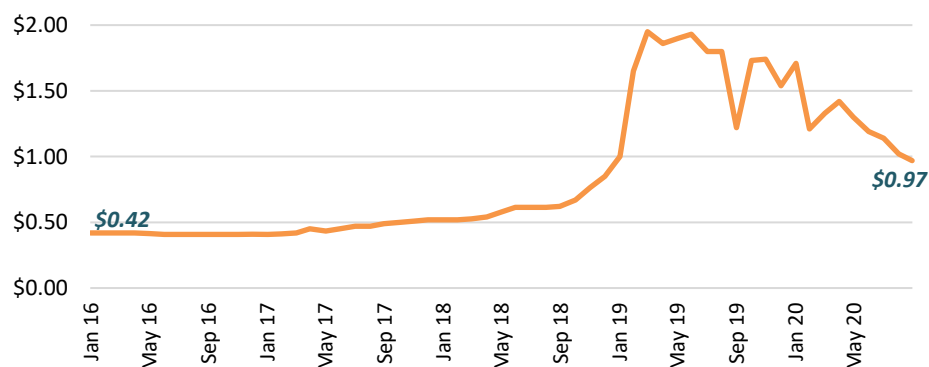

## SHARE PRICE PERFORMANCE

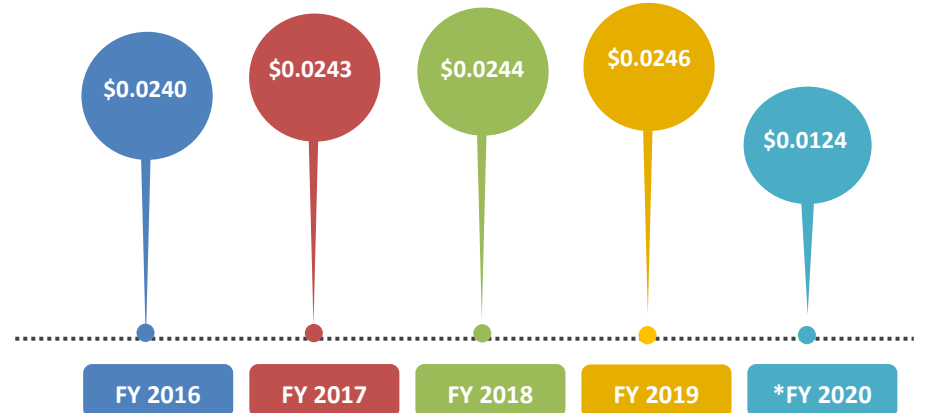
From January 2016 until the most recent

## DIVIDEND PAYMENT HISTORY

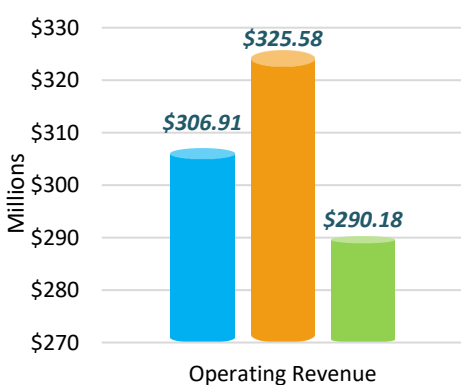
Dividend per share from 2016 until 2020 (based on financial year)



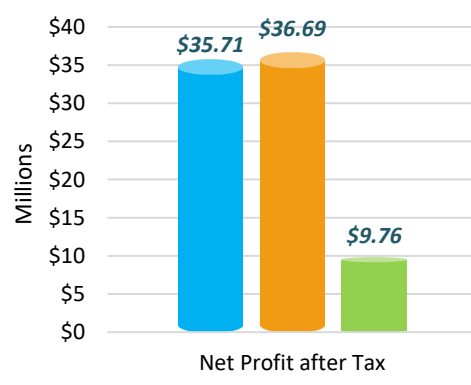

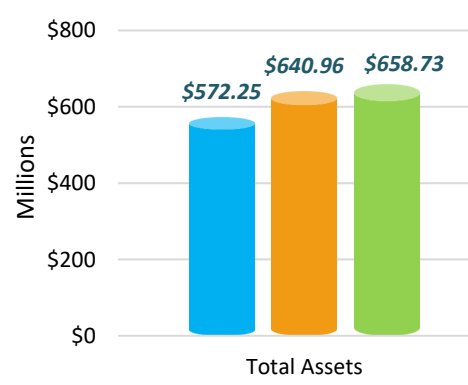
### Operating Revenue



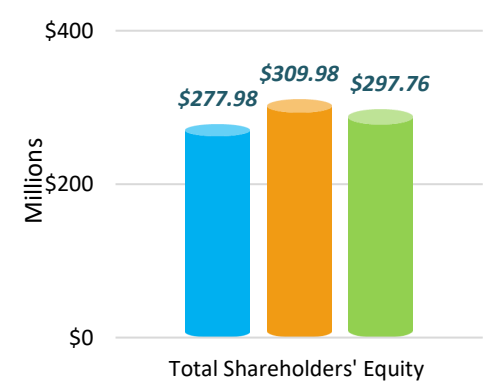
### Net Profit after tax
