## ANNOUNCEMENT OF DIVIDEND REINVESTMENT PRICE

As announced through the South Pacific Stock Exchange ("SPX"), Pleass Global Limited (PBP) declared the interim dividend for 2020 as \$0.02 (two cents) per share. Under PBP's Dividend Reinvestment Plan, shareholders have the opportunity to reinvest the dividend into additional shares of PBP. The Reinvestment Price will be \$2.71 per share. The Reinvestment Price is set at a 5% discount to the last traded share price prior to the dividend announcement.

Reinvestment into additional shares can be made without paying any brokerage fees or levies. Shareholders who elect to participate in the reinvestment plan will receive newly issued shares. The number of shares will be equal to the total amount of dividend to which the shareholder is entitled (\$0.02 multiplied by the number of shares owned) divided by \$2.71 (Dividend Reinvestment Share Price). The number of shares will be rounded down to the nearest whole number. Everyone who is registered as a shareholder in PBP as of 12<sup>th</sup> November 2020 is eligible to elect to participate into the re-investment plan.
