



#### **OVERALL MARKET COMMENTARY:**

- The market capitalisation for the week recorded an increase of 1.32% and concluded at \$3.44 billion. The increase was mainly due to positive share price movement recorded for Toyota Tsusho (South Sea) Limited (TTS).
- Kontiki Finance Limited (KFL) and Fijian Holdings Limited (FHL) recorded negative price movements while share price for Amalgamated Telecom Holdings Limited (ATH) and FijiCare Insurance Limited (FIL) remained unchanged.
- \$ 21 transactions with an aggregate volume of 28,756 shares and value of \$32,916 were recorded amongst which, five securities recorded market activities.
- The market capitalisation weighted Total Return Index (STRI) recorded an increase of 1.32% while the Equal Weighted Price Index (EWPI), which weighs all listed entities equally, rose by 0.76%.
- On year-to-date basis, the SPX Total Return Index shows a fall of 5.46% (-463.03 points) while Equal Weighted Price Index stands higher by 10.91% (+502.88 points).
