OVERALL MARKET COMMENTARY

- Market value for the week recorded a marginal increase of 0.08% and concluded at \$3.18 billion resulting from increase in share prices for FHL and BCN. RBG was the only stock to record a share price fall this week while share prices for remaining stocks recording market activities remained same as the previous week.
- Trading statistics showed an improvement in comparison to the previous week as 30 transactions were recorded in 8 listed stocks with a volume of 10,607 shares and a value of \$23,728.
- As for market indices, the SPX Total Return Index (STRI) rose by 0.38% while the Equal Weighted Price Index (EWPI), which weighs
 all listed entities equally, rose by a lower 0.18%.
- The market also recorded dividend returns of 0.63% and 1.09% from PBP and ATH respectively. PBP Shareholders will receive their dividend payment on 19th January 2022 while ATH shareholders will receive their dividend payment on 24th January 2022.
- The SPX continues to monitor the Equal Weighted Price Index on a daily basis whereby a 5% movement within a given trading day will warrant a temporary trading halt.
