

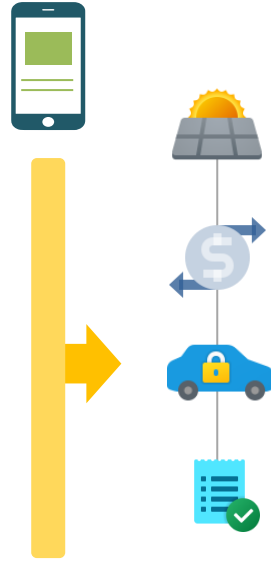

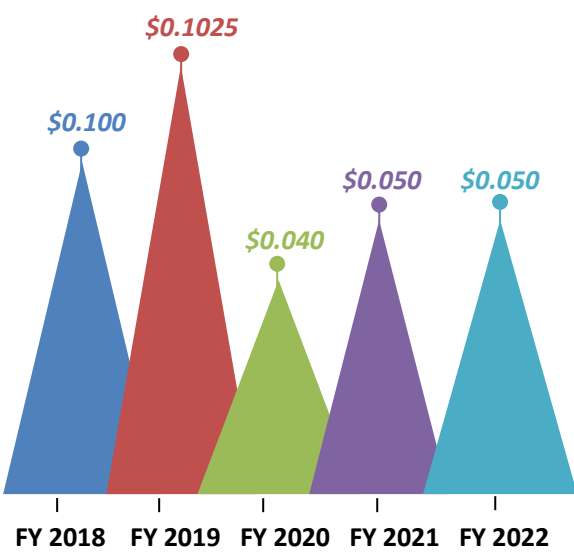

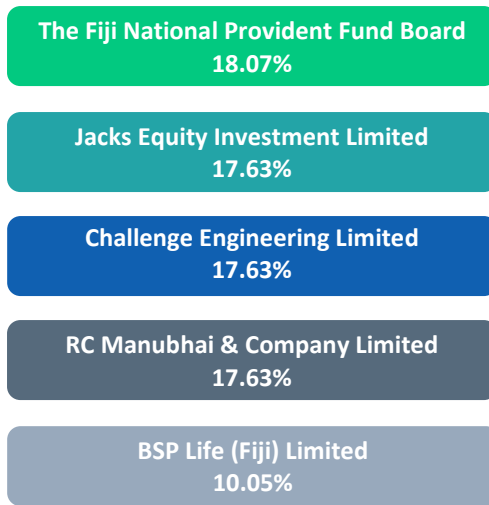

From 2018 until 2022 (based on financial year)

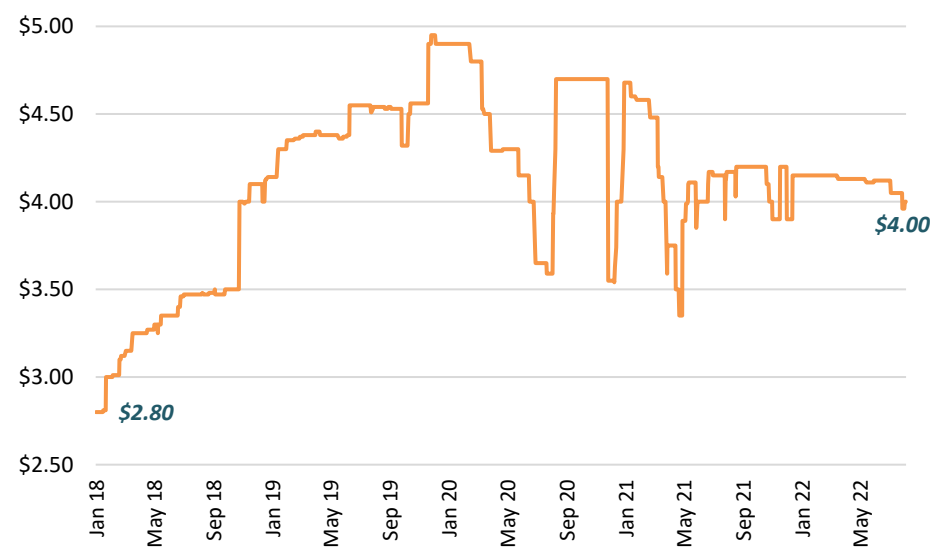


TOP 5 SHAREHOLDERS

From 2018 until the most recent

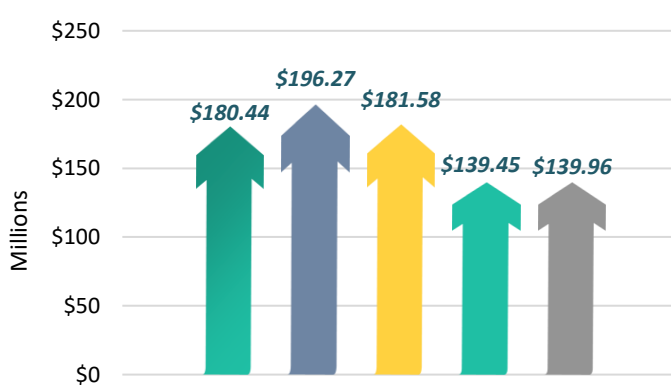


STATISTICAL HIGHLIGHTS (Apr 2021 - Mar 2022)



FINANCIAL FIGURES TREND (over past 5 years)

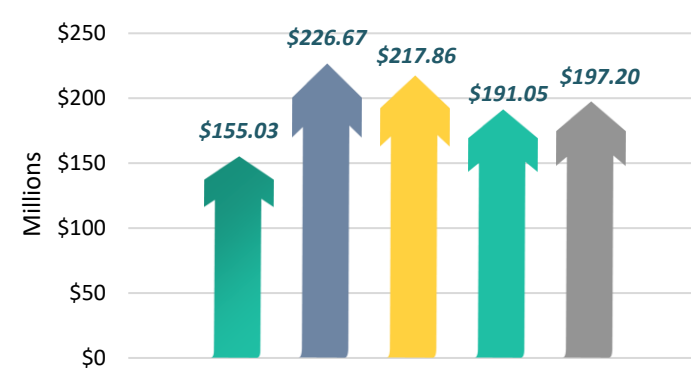
Operating Revenue



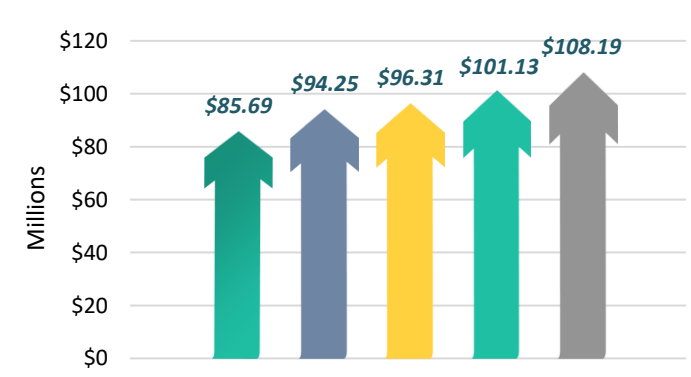
Net Profit after Tax
