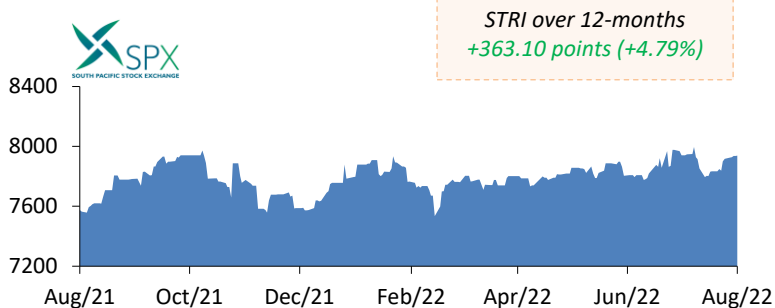

## OVERALL MARKET COMMENTARY

- During the week, 22 transactions in 8 listed securities with a volume of 85,212 shares and a value of \$205,921 were recorded.
- The market value for this week rose marginally by 0.26% and concluded at \$3.18 billion. This was due to increase in share price for securities; APP, FBL, FIL, and VIL. RCF was the only security to record negative price movement while KFL, PDM and TTS share prices remained same as previous week.
- The SPX Total Return Index (STRI) rose marginally by 0.26% while the Equal Weighted Price Index (EWPI), which weighs all listed entities equally, rose by a higher 1.94%.
