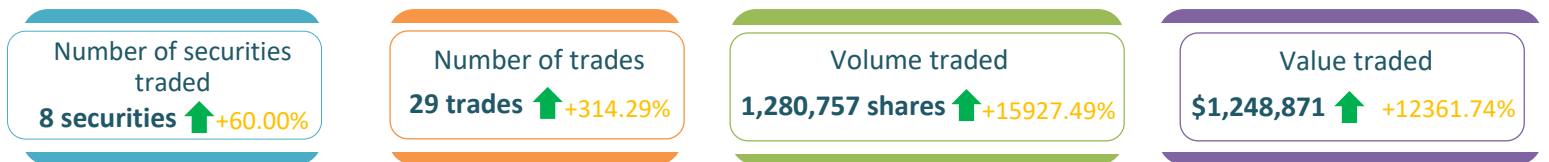

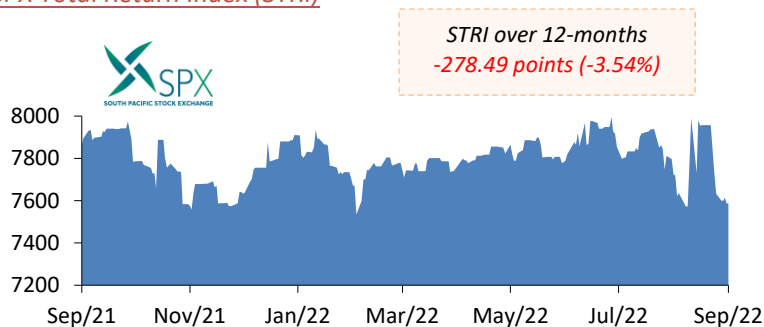

OVERALL MARKET COMMENTARY

- Trading on the SPX e-platform during the week was active and stood noticeably higher in comparison to the prior week. This was due to negotiated deal transactions executed in KFL shares. In aggregate, 29 transactions were recorded in 8 listed securities with a volume of 1,280,757 shares and a value of \$1,248,871.
- The market value for this week recorded a decrease of 0.74% and concluded at \$3.02 billion. The decrease is due to the negative share price returns noted in FIL, FMF and FHL shares.
- The SPX Total Return Index (STRI) fell by 0.61% while the Equal Weighted Price Index (EWPI), which weighs all listed entities equally, fell by a lower 0.54%.
- During the week, the market also recorded dividend returns of 0.84% and 0.57% generated by RBG and CFL respectively. RBG shareholders should anticipate to receive their dividend proceeds by 23rd September 2022 while CFL shareholders will receive their dividend proceeds by 26th September 2022.
