BSP update on unauthorised third-party access to Test Environment

On 26 May 2026, BSP Financial Group Limited (BSP) (ASX: BFL / PNGX: BSP) announced it had identified unauthorised third-party access to its non-production Test Environment.

On detection, BSP took immediate containment action and commenced an investigation with leading international cybersecurity and forensic experts.

Importantly, the investigation has confirmed there is no evidence of unauthorised access to BSP's production systems or customer accounts.

Customer funds remain secure, and all customer banking services continue to operate as normal.

The investigation has confirmed that a portion of the Test Environment dataset was taken by the third-party.

BSP has no reason to believe that data taken from the Test Environment will become available in the public domain. BSP is monitoring closely for any such activity.

BSP has engaged early and constructively with relevant regulators on this matter.
