Papua New Guinean domiciled investors who migrate their shares to the ASX receive dividends in Kina. Should a Papua New Guinean domiciled shareholder move their shareholding to the Australian share register together with a transfer to an Australian-based fund manager, or custodian (on the basis that the shareholding will still be under the control of the Papua New Guinean shareholder), dividends would continue to be made in Kina.
