**Pleass Global Announces Final Dividend 2025**

Chairman Warwick Pleass commented;

“The Company paid an interim dividend of 8 cents per share in August 2025 and declared a final dividend of 12 cents per share in February 2026. Accordingly, the total dividend declared for the whole of the 2025 financial year is 20 cents per share. (2024: 16 cents per share).

The outlook for the business remains strong, underpinned by a strong export order book and we have adequate unused production capacity. We are ready for continued growth in 2026 and onwards. New customer-owned brands, as well as the company's own brands of AquaSafe® Natural Artesian Water and VaiWai® Natural Artesian Water, provided the growth and the increase in profit”.
