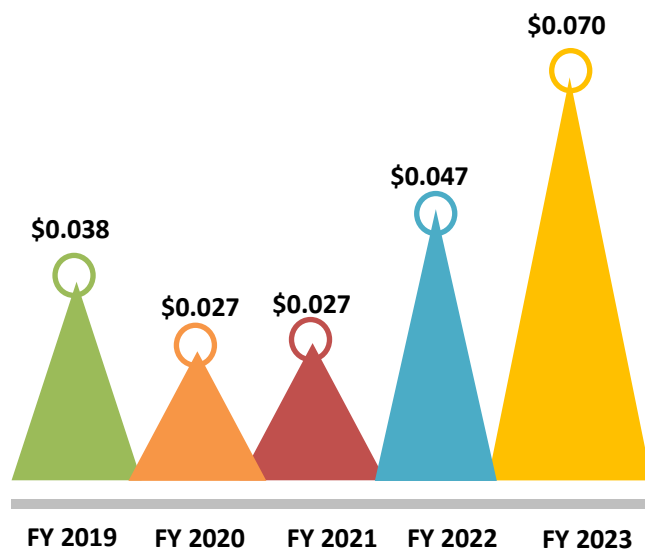

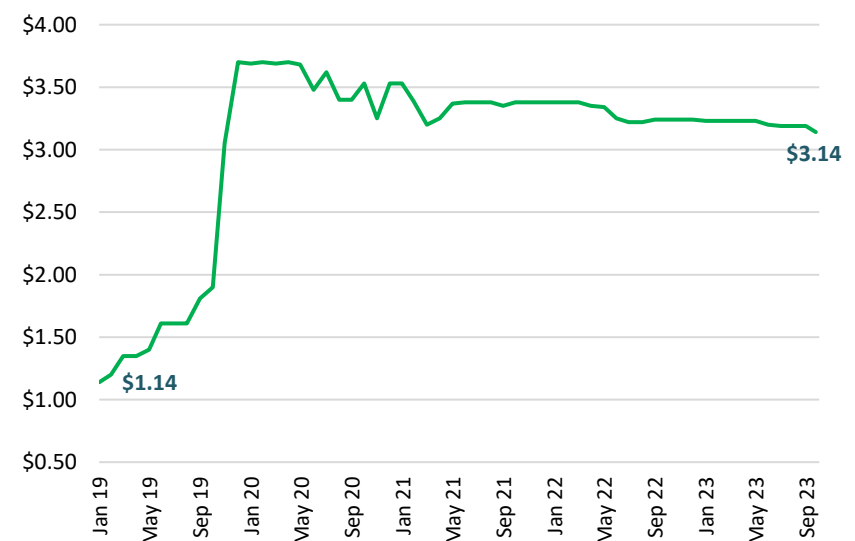
### DIVIDEND PAYMENT HISTORY

From 2019 until 2023 (based on financial year)



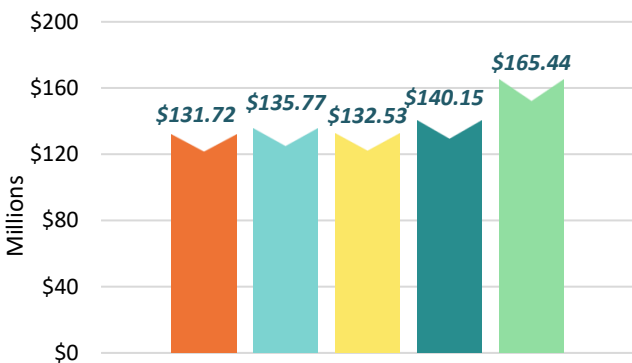
### SHARE PRICE TREND

From 2019 until the most recent

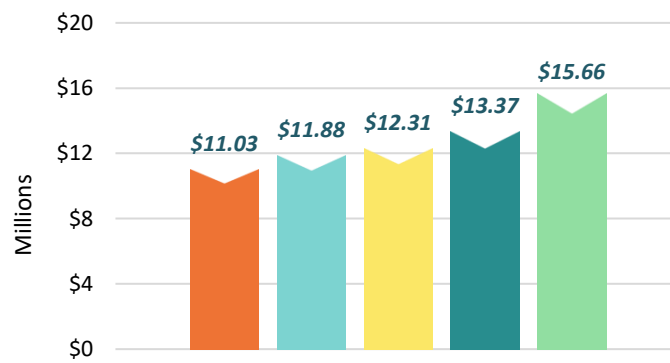


### FINANCIAL FIGURES TREND (over past 5 years)

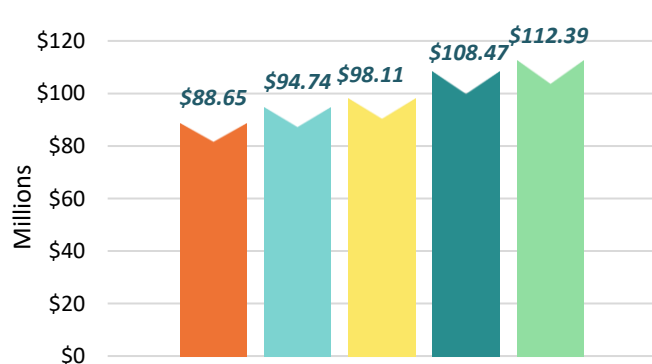
#### Operating Revenue



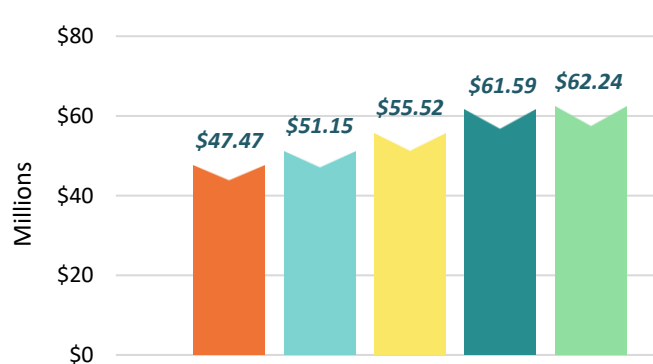
#### Profit from Operations
