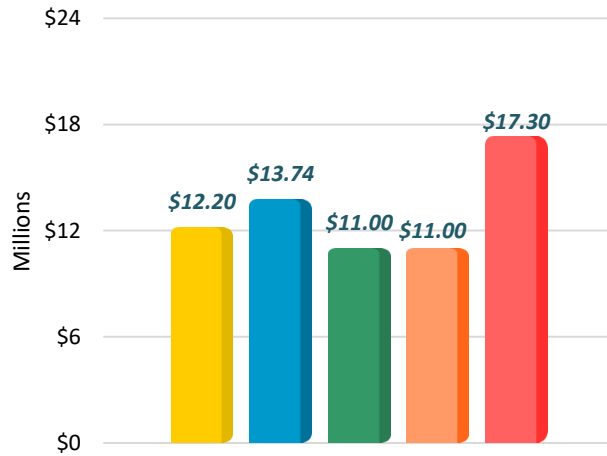

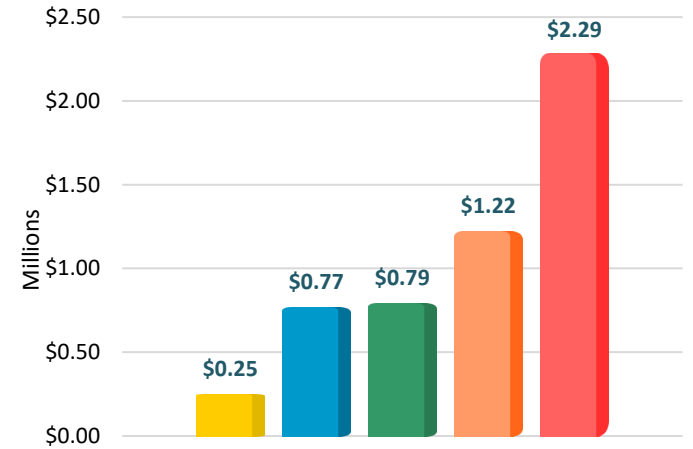

FINANCIAL FIGURES TREND (over past 5 years)

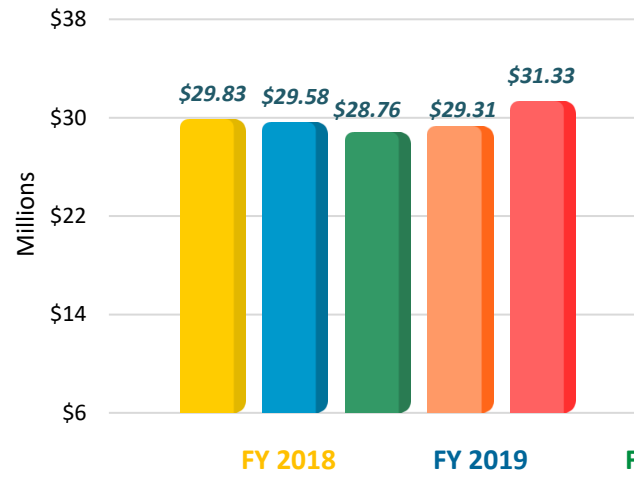
Operating Revenue



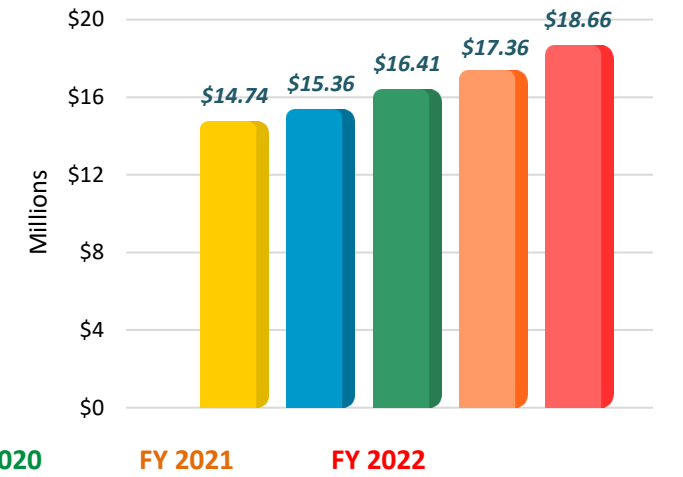
Profit from Operations



Total Assets



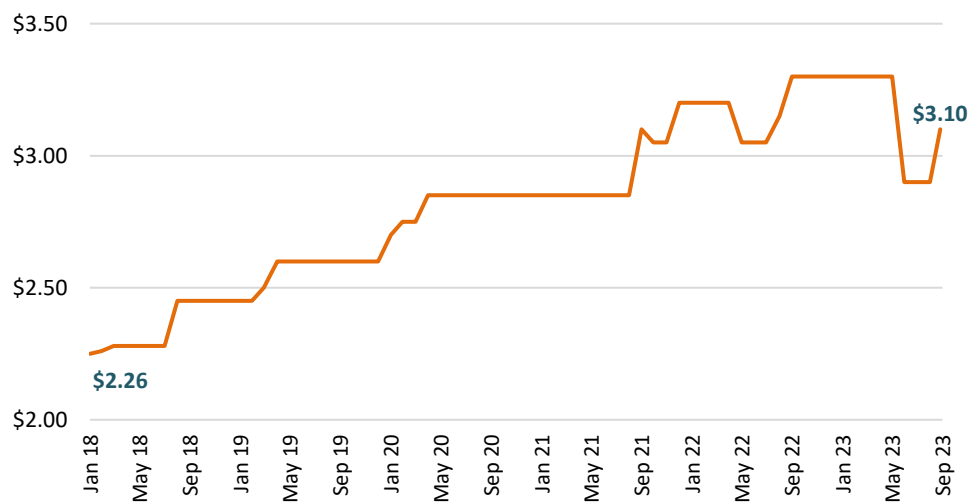

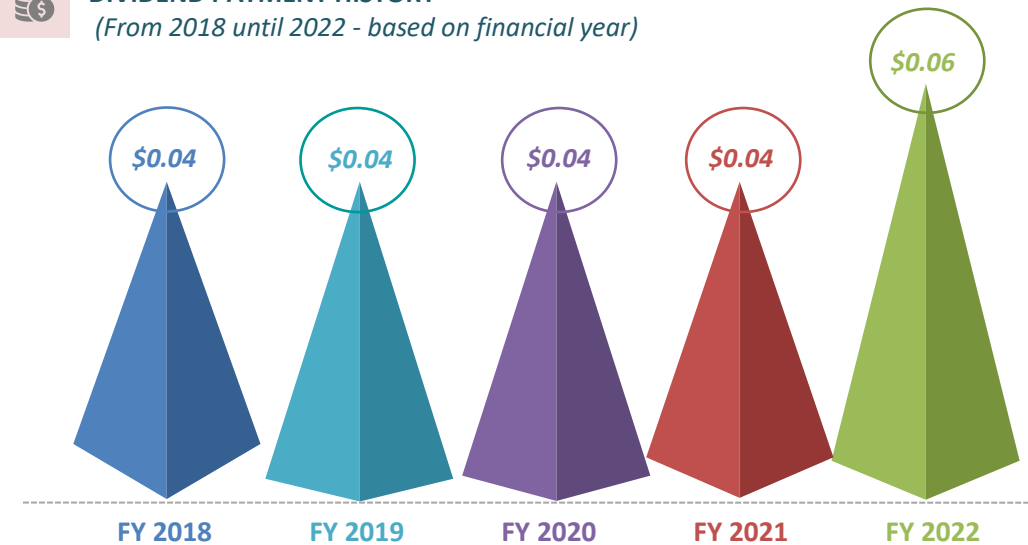
