VNPF Acquires 14% Stake in Telecom Vanuatu Limited T/A Vodafone Vanuatu

Amalgamated Telecom Holdings Limited ("ATH") and the Vanuatu National Provident Fund ("VNPF") are pleased to announce that VNPF has acquired a 14% shareholding in Telecom Vanuatu Limited, trading as Vodafone Vanuatu, a subsidiary of ATH.

This acquisition builds on a longstanding and mutually beneficial partnership between ATH, Vodafone Vanuatu and VNPF. In 2017, VNPF provided an VT\$800 million loan, enabling the acquisition of Vodafone Vanuatu and the subsequent upgrade and expansion of mobile infrastructure across Vanuatu. This investment allowed Vodafone Vanuatu to grow into the country's largest mobile operator while providing attractive returns to VNPF and its members.
