MARKET ANNOUNCEMENT

- Delay in releasing 2025 audited financial statements.

Free Bird Institute Limited wishes to advise shareholders and the market that there will be a delay in the release of its audited financial statements for the financial year ended 31 December 2025.

The delay is primarily due to the acquisition of South Pacific Free Bird Co. Ltd. in September 2025. As a result, the Company is required to undertake a full consolidation of financial statements, including the conversion of the subsidiary's financial information from Japanese GAAP to International Financial Reporting Standards (IFRS). This process requires additional time to ensure that both entities' financial statements are properly aligned and fully compliant with IFRS requirements.

The Company, together with its auditors, is working diligently to complete this process and ensure that all necessary disclosures are accurate and in accordance with applicable standards.

In the interest of maintaining an informed and orderly market, the Company has sought a voluntary suspension of trading of its shares. Accordingly, trading will be temporarily suspended until the audited financial statements are finalised and released to the market.

The Company anticipates releasing the audited financial statements in due course and will keep the market informed of any further developments.

Free Bird Institute Limited remains committed to transparency and to providing shareholders with comprehensive and reliable financial information.

The Company appreciates the understanding and continued support of its shareholders.
