The Fiji Police Force and Port Denarau Marina Limited (PDML) have formalized their collaboration in border control, surveillance, enforcement, and security through a Memorandum of Agreement (MOA) signed on the 28th of January, 2025. As Fiji's premier tourist hub and a key Port of Entry, this partnership highlights a shared commitment to ensuring safety and security for visitors, stakeholders, and the local community.

Under this agreement, PDML has provided a dedicated Police booth to support law enforcement operations and maintain order at the facility. Additionally, a designated berth has been allocated for police patrol boats, enhancing water-based surveillance and response capabilities. Acting Commissioner of Police Juki Fong Chew emphasized the importance of this collaboration in protecting all those who visit and operate within Port Denarau.

"The Fiji Police Force is glad that this partnership has finally materialized. Moving forward, we can continue to work together to minimize issues that affect tourists and anyone coming to Port Denarau," said Mr. Chew.

He further stated that working closely with PDML and other stakeholders would strengthen efforts to combat crime, including transnational threats such as drug trafficking.
Enhancing Security & Border Control

While Port Denarau Marina has historically been considered a safe and well-managed area with low crime rates, the MOA is a proactive initiative aimed at enhancing security measures and mitigating potential risks before they escalate.

Key measures under the agreement include:

- Increased Police Presence - Establishment of a dedicated police booth, provided by PDML, to serve as a base for security operations.
- Police Patrol Boats - Allocation of berthing space for police patrol boats to strengthen water-based surveillance.
- Integrated Security Collaboration—Strengthened coordination between port security personnel and the Fiji Police Force to enhance response times and enforcement.
- Enhanced Monitoring & Control - Improved surveillance, including regular patrols and intelligence-sharing to combat illicit activities such as drug trafficking.
- Compliance with International Security Standards - As an ISPS-compliant port, PDML upholds strict security protocols, and this agreement strengthens enforcement of these measures.

While the Fiji Police Force has maintained a presence at Port Denarau Marina for several years, this MOA marks the first formalized agreement that strengthens their role in border security and law enforcement at the port.

About Port Denarau Marina

Located just a 20-minute drive from Nadi International Airport, Port Denarau Marina is Fiji's premier marina facility and the gateway to the stunning tropical isles of Fiji's West Coast. As the hub of the integrated Denarau Island Resort, it serves as the central point for travelers and yachting enthusiasts exploring the region.

Port Denarau Marina offers convenient access to essential services, with a supermarket, pharmacy, and bakery right at the dock. Additional shopping and provisioning options are available in nearby Nadi and Namaka, just a short bus or taxi ride away.

Within walking distance of several international hotels, the marina is surrounded by a wide range of recreational activities, including an 18-hole championship golf course and Fiji's largest retail and restaurant complex. Whether for a short stopover or extended cruising, Port Denarau Marina is ideally positioned to provide rest, recreation, and provisioning services for visitors navigating the Fijian Islands.

As Fiji's leading yachting hub, Port Denarau Marina is accessed through a well-marked channel with a depth of 5 meters at zero tide, ensuring safe entry for vessels. The marina is well-protected from all weather conditions and features:

- 63 commercial and 56 fully serviced private berths
- 16 swing moorings
- 20 berths for Superyachts up to 85 meters with a 5-meter draft
- Fuel, water, single and three-phase power, and Wi-Fi at the dock
- A 50-tonne travel lift, hardstand area, and marine workshops
